

**ORDER APPROVING APPLICATION OF MASONITE
CORPORATION, INC. FOR RENEWAL OF TAX EXEMPTION
FROM AD VALOREM TAXES ON THE FREEPORT
WAREHOUSE AS AUTHORIZED BY SECTION 27-31-51
THROUGH SECTION 27-31-61, CODE OF 1972, AS AMENDED.**

There came on for hearing before the Council of the City of Laurel, Jones County, Mississippi, the sworn application of Masonite Corporation, Inc. for an exemption from ad valorem taxation for inventory values in their Freeport Warehouse located at 1001 S. 4th Avenue, Laurel, Mississippi, under provisions of Section 27-31-51 through 27-31-61 Code of 1972 Annotated as amended; the Council having considered same and being fully advised in the premises finds as follows:

I.

That Masonite Corporation, Inc. is qualified to do business in Mississippi with its registered office at 1001 South 4th Avenue, Laurel, Mississippi.

II.

That Masonite Corporation, Inc., is a manufacturing concern operating a hardboard manufacturing facility with a State of Mississippi licensed Freeport Warehouse in Laurel, Jones County, Mississippi.

III.

That the exemption should be granted.

IT IS THEREFORE ORDERED, that the application of Masonite Corporation, Inc. for renewal of an exemption from ad valorem taxation for inventory values in the Freeport Warehouse located at 1001 South 4th Avenue, Laurel, Mississippi, be approved; that renewal of exemption is hereby granted, and that the inventory of Masonite Corporation, Inc. certified as eligible with the State Tax Commission of the State of Mississippi be and it is hereby exempt from all ad valorem taxation as provided by law for a period of one (1) year from and after January 1, 2026.

Motion was made by Councilperson Capers, seconded by Councilperson Scruggs, that the above and foregoing Order be adopted.
