

## **ORDER**

**(Authorizing Mayor Johnny Magee, Acting on Behalf of the City of Laurel, to Sign an Agreement for Maintenance Services for City Generators)**

**WHEREAS**, the City of Laurel's existing agreement with Taylor Power Systems for maintenance of City generators at certain City buildings has expired and is in need of renewal; and

**WHEREAS**, the City's existing agreement with Taylor Power Systems for maintenance of City generators at the Water Department expires in December 2025 and is in need of renewal; and

**WHEREAS**, Taylor Power Systems has presented agreements for maintenance of the aforementioned generators, the details of which are outlined in **Exhibit A**, attached hereto, which lists the fees for generators in City departments of Police, City Hall, Recreation, and Fire totaling six thousand five hundred and eighty-one dollars (\$6,581.00), and in **Exhibit B**, attached hereto, which lists the fees for the generators in the Water Department totaling fourteen thousand five hundred fifty-three dollars (\$14,553.00)

**NOW THEREFORE, IT IS ORDERED** by the Laurel City Council that Mayor Johnny Magee, acting on behalf of the City of Laurel, be authorized to sign the following:

**Exhibit A:** Taylor Power Systems Standby Generator Industrial Maintenance Service Agreement, in the amount of six thousand five hundred and eighty-one dollars (\$6,581.00); Agreement Period: (retroactively) October 2025 to October 2026.

**Exhibit B:** Taylor Power Systems Standby Generator Industrial Maintenance Service Agreement, in the amount of fourteen thousand five hundred fifty-three dollars (\$14,553.00); Agreement Period: December 2025 to December 2026.

**IT IS FURTHER ORDERED** that the Finance Director be authorized to perform whatever budgetary transactions are necessary for implementation of the foregoing Order.

Motion is made by Councilperson Kelly, and seconded by Councilperson Scruggs, that the foregoing Order be adopted.
