ORDER

(Authorizing FY2025 Agreement between the City of Laurel and the Organized Crime Drug Enforcement Task Force Regarding Reimbursement of Overtime Payment and Authorized Expenses for Participating Laurel Police Department Personnel)

WHEREAS, the Organized Crime Drug Enforcement Task Force, has submitted for approval an agreement, a copy of which is attached hereto as **Exhibit A**, which allows for reimbursement of overtime and authorized expenses, not to exceed twenty-one thousand seven hundred forty dollars and fifty cents, (\$21,740.50) for certain Laurel Police Department personnel participating in the OCDETF FY2025 State and Local Overtime and Authorized Expenses/Strategic Initiative Program; and

WHEREAS, the Laurel Police Department agrees to allow Sergeant Donna Michelle Howell to participate in and assist the OCDETF FY2025 State and Local Overtime and Authorized Expense/Strategic Initiative Program; and

WHEREAS, the Laurel City Council now finds that it is in the best interest of the City of Laurel that the Laurel Police Department agree to allow experienced Sgt. Donna Michelle Howell to assist in the aforementioned program

NOW THEREFORE, IT IS ORDERED by the Laurel City Council that Mayor Johnny Magee is authorized to sign the Organized Crime Drug Enforcement Task Force FY2025 State and Local Overtime and Authorized Expense/Strategic Initiative Program Agreement (**see Exhibit A**), with reimbursement of funds to the City not to exceed twenty-one thousand seven hundred forty dollars and fifty cents, (\$21,740.50). Laurel Police Sgt. Donna Michelle Howell is authorized to participate in the aforementioned program under terms and conditions of the one-year agreement. **IT IS FURTHER ORDERED** that the Finance Director be authorized to perform whatever budgetary transactions are necessary for implementation of the foregoing Order.
