

## ORDER

### (Authorizing the Administration to Renew an Agreement with Granicus to Provide Council Meeting Software)

**WHEREAS**, the City of Laurel, by order of March 5, 2019, entered into an agreement with Granicus, Inc. to provide the City of Laurel with Agenda Management Software to increase communication, efficiency, and transparency; and

**WHEREAS**, said agreement will expire on February 28, 2026, and is in need of renewal. As outlined in the 2019 agreement term, the Granicus Products and Services automatically renew at the end of each term for an Extension Term of One (1) year; and

**WHEREAS**, the terms and conditions of the new agreement, attached hereto as Exhibit A, are set forth and incorporated by reference in the 2019 agreement. The renewed one-year subscription rate is sixteen thousand six hundred sixty-seven dollars and eleven cents (\$16,667.11) with charges billed in quarterly installments to the City Council Maintenance and Service Contract Account 001-100-638.0. The term is effective from March 1, 2026 until February 28, 2027;

**NOW THEREFORE, IT IS ORDERED** by the Laurel City Council that the City of Laurel, MS, be authorized to renew an agreement with Granicus, Inc., to provide Council Meeting Management software. The renewed one-year subscription rate is sixteen thousand six hundred sixty-seven dollars and eleven cents (\$16,667.11) with charges billed in quarterly installments to the City Council Maintenance and Service Contract Account 001-100-638.0. The term is effective from March 1, 2026 until February 28, 2027;

**BE IT FURTHER ORDERED** that Mayor Johnny Magee, acting on behalf of the City of Laurel, is authorized to sign any and all documents necessary to secure the services of Granicus, **AND FURTHER** that the Finance Director be authorized to perform whatever budgetary transactions are necessary for implementation of the foregoing Order.
