The proposal shall include a clear table of contents addressing all the requirements of the RFP.

- 3. Availability of supplier for full-time design, construction & installation services, and able to complete construction/installation in a timely manner.
- 4. Experience in construction/installation of playground equipment which includes inclusive playground equipment and surfacing, site prep (including drainage).
- 5. Ability to provide personnel based in close proximity to the City of Laurel for the duration of the project.
- 6. Warranty of the Project.
- 7. The firm should have a complete understanding of the City of Laurel, State of Mississippi and Federal Construction & Environmental Regulations.
- 8. Design of an Inclusive Playground to include ADA ramp zero entry, with safety surfacing with IPEMA-certified engineered wood fiber (or equivalent), site prep (including drainage and installation within a budget of \$350,000.
- 9. Design must use color tones to match Mason Park environment.
- 10. Provide Construction Start Time and Completion Time.
