

ORDER

(Approving the Purchase of Forty-two (42) Tasers and (42) Forty-two Cameras from Axon Enterprises, Inc., a Sole Source Provider, under a Five-Year Lease-Purchase Plan, and Authorizing Mayor Johnny Magee, Acting on Behalf of the City of Laurel, to Sign an Agreement for Same)

WHEREAS, the Laurel Police Department wishes to purchase forty-two (42) Tasers and (42) forty-two Cameras from Axon Enterprise, Inc., a sole source provider, as attested in a letter, a copy of which is attached hereto as Exhibit A; **and**

WHEREAS, Axon Enterprise, Inc. has submitted for approval an agreement, a copy of which is attached hereto as Exhibit B, for the purchase of said tasers and cameras under a five-year lease-purchase plan in the amount of \$466,143.75. The payment of \$74,555.63 will be for the first year followed by the amount of \$97,897.03 for the remaining four years; **and**

WHEREAS, the Laurel City Council now finds that it is in the best interest of the City of Laurel that the Laurel Police Department be equipped with the aforementioned tasers and cameras

NOW THEREFORE, IT IS ORDERED by the Laurel City Council that the purchase of forty-two (42) Tasers and (42) forty-two Cameras at a total cost of four hundred sixty-six thousand, one hundred forty-three dollars and seventy-five cents (\$466,143.75) from Axon Enterprise, Inc. be approved under terms and conditions of the five-year lease-purchase agreement submitted by that firm with funds to be taken from the Specific Operating Fund of the Laurel Police Department Budget (#001-200-539.0). **IT IS FURTHER ORDERED** that Mayor Johnny Magee, acting on behalf of the City of Laurel, be authorized to sign the agreement for same, **AND FURTHER** that the Finance Director be authorized to perform whatever budgetary transactions are necessary for implementation of the foregoing Order.

Motion was made by Councilperson Kelly, seconded by Councilperson Capers, that the above and foregoing Order be adopted.
