**POLLING PLACE AGREEMENT**

**WHEREAS**, the City of Laurel, Mississippi, desires to use Christ Church, located at 1301 N 2<sup>nd</sup> Avenue, Laurel, Mississippi, as a voting station for Ward 4 for City elections; and

**WHEREAS**, Christ Church, has agreed to allow the City of Laurel, Mississippi, to use free of charge its facility located at 1301 N 2<sup>nd</sup> Avenue, Laurel, Mississippi, as a voting station for City elections.

**NOW, THEREFORE**, the City of Laurel and Christ Church do hereby agree as follows:

1. The City of Laurel, Mississippi, shall provide written notice of said election dates to Christ Church at least 30 days prior to any election.
2. The City of Laurel agrees to perform the setup and cleanup for any City elections held at the facility.
3. The City of Laurel will also indemnify and hold harmless Christ Church from any damages suffered as a result of injuries to poll workers and/or voters due to the negligence of the City of Laurel, Mississippi, or its employees.
4. Christ Church agrees to provide reasonable access to the facility prior to and after any City election for setup and cleanup by the City of Laurel.
5. Either the City of Laurel or Christ Church may terminate this Agreement by giving at least 180 days written notice with either delivery method at the address shown.
