3. Special Exception Docket No. SPE 24-11, styled Alaina M. Rowzee, 1922 Pearl St. Laurel, MS 39440, requesting a special exception to establish an in-home daycare on the property described below:

BRYANT SUB-DIV BLK A (City of Laurel/Jones County Parcel No. 119N-12-11-039.00 PPIN 8566. Also known as 1922 Pearl St.

This property is located in Ward 1 and currently zoned R-2, Medium Density Residential District. Requested use is permitted in C-1, Restricted Commercial District.

Discussion: Alaina Rowzee was present to speak in favor of the Special Exception request. She stated that she has been before the board for a request at a different location. She is now wanting to operate at her home, and wants to obtain license from the State of Mississippi in order to have more children enrolled. She has spoken to adjoining neighbors and they are all supportive of her business. Mrs. Vincent asked if she has been inspected by the Health Department. Ms. Rowzee stated she has all credentials needed to operate an in-home daycare. She has to have the Fire Department inspect and approval from the city before she can open for business. Mrs. Vincent asked how many children will be enrolled? Ms. Rowzee explained that without license she is considered a babysitter, and only allowed 5 children, but once she obtains her license, she is allowed up to 12. Mrs. Vincent asked which hours would she operate, and she stated, 7:30 am - 5:30 pm, Monday through Thursday, and close at 5:00 pm on Friday. There were no questions from the Committee, and there was no one there to oppose.
