- 2. Provide and install Miracle playground equipment based off of the design and project information provided by the city of Laurel.

Contract Price and Payments

- 3. Owner agrees to pay Magnolia Recreation the total amount of \$349,843.20. Payment of this amount will be broken out as follows:
 - -Payment 1 of \$100,875.10 will be due upon the order of equipment
 - -Payment 2 of \$100,875.10 will be due upon the delivery of equipment
 - -Payment 3 of \$148,093.00 will be due upon completion of project
 - -Payment terms amounts payable will be due within 15 days from the date invoiced
