Due to volatile fuel pricing , Knight Coach will provide final pricing to customer ,
including fuel surcharges. Surcharges should be a minimum of 3% of original quote
based on \$ 5.50 gallon fuel. Surcharges will be accessed 10 days before trip
departure based on fuel pricing for that date.

TERMS AND CONDITIONS

PAYMENT TERMS: Payment is to be made according to the requirements listed above.
Payment may be made by check, money order, cash, credit or debit card. **Payments**
made with credit or debit card will incur a 3.5% upcharge.

PRICING: Pricing is based according to the information given at the time of booking and may change according to the actual itinerary. Charters going over their allotted time and mileage will be billed accordingly. Final Pricing will be based on final itinerary which may increase or decrease total bus price. Chartering party is responsible for all tolls, parking, ferry and entrance fees for the motor coach. Chartering party is responsible for DRIVER HOTEL ROOM on overnight trips (our policy is one room per driver).

ITINERARIES: Written and detailed itineraries are required in our office 14 days prior to trip departure. Information should include names and addresses of all locations to be visited during trip.

DRIVER REGULATIONS: Federal regulations allow drivers to be on duty 15 hours per day with a maximum of 10 hours of driving time. A driver must then have 8 consecutive hours off duty. We require at least a 9 hour break on overnight charters to allow for proper post trip and pre trip vehicle inspections.

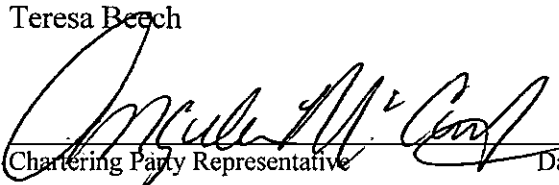
FOOD AND BEVERAGE: Light snacks only are allowed on board the motor coach. We do not allow fast food, including ice cream, or anything greasy that would risk staining the seats. Twist top drinks only are allowed, no cans or cups with lids.

LOST ITEMS: Knight Coach, Inc. is not responsible for any items left, lost or misplaced on board the motor coach. Group leader should check the bus at end of trip to insure nothing is left behind.

GROUP LEADER RESPONSIBILITY: Group leader is to see that the group remains orderly and that they do not damage the vehicle or equipment. Leader is to keep passengers from potentially harming themselves by sitting on arm rests, standing in seats or leaning backward over the seats. We recommend that everyone remain seated while the motor coach is moving. Motor coach should be kept clean, chartering party will be held responsible for damage and any excessive cleaning other than routine. There will be a \$100 charge for anything deposited in the toilet other than human waste and toilet paper.
