

**ORDER APPROVING APPLICATION OF WAYNE SANDERSON FARMS LLC,
FOR
TAX EXEMPTION FOR A PERIOD OF TEN YEARS AS
AUTHORIZED BY SECTION 27-31-101, ET SEQ.,
MISSISSIPPI CODE OF 1972 AS AMENDED.**

There came on for hearing this day before the Mayor and Council of the City of Laurel, Jones County, Mississippi, the sworn application of Wayne Sanderson Farms, LLC., for an exemption from ad valorem taxation, except state ad valorem taxation, ad valorem taxes for school district purposes and “mandated municipal levies”, of all of its tangible property used in connection with and necessary to the operation of said Wayne Sanderson Farms, LLC., a poultry processing facility in the City of Laurel, Second Judicial District, Jones County, Mississippi, under provisions of Section 27-31-101, et seq., Mississippi Code of 1972 Annotated, as amended and other pertinent statutes; the Mayor and Council having considered same and being fully advised in the premises finds as follows:

I.

That Wayne Sanderson Farms, LLC. is operating as an Agricultural Processing / Production / Feed Mill – Poultry type of industry within the City of Laurel, County of Jones, Mississippi, which factory is a bona fide expanded enterprise of “public utility” within the meaning of Section 27-31-105 et seq., and related Sections of the Mississippi code of 1972, as amended, and is eligible for the exemption granted by the above mentioned section by specific enumeration, namely “manufacturing, processors, and refineries”

II.

That Wayne Sanderson Farms, LLC' Feed Mill located within the City of Laurel, Jones County, Mississippi at 2600 Warehouse Dr. Laurel, Mississippi, 39440.

That the exemption herein requested is for new improvements which were completed on or about December 31, 2025, at Wayne Sanderson Farms, LLC. processing facility in Laurel, Jones County, Mississippi. All of the new improvements will be used for said poultry processing purposes, and the true value of the new improvements is **\$307,586.08**, as demonstrated by an itemization thereof attached hereto and incorporated herein as collective Exhibit "A".

IT IS, THEREFORE, ORDERED subject to the approval of the State Tax Commission, that the application of Wayne Sanderson Farms, LLC., for an exemption from ad valorem taxation, except state ad valorem taxation, ad valorem taxes for school district purposes and "mandated municipal levies" be and it is hereby granted, and that all the property described in said application, and exhibited thereto, in the amount of **\$307,586.08** and it is hereby exempted from all ad valorem taxation except state ad valorem taxation, ad valorem taxation for school district purposes and "mandated municipal levies", for ten years commencing 1st day of January, 2026 and ending the 31st day of December, 2035.

IT IS FURTHER ORDERED, that the Clerk shall transmit a certified copy of this Order, to the State Tax Commission, thereby signifying the desire of the Mayor and City Council of the City of Laurel, Jones County, Mississippi, that said Board shall approve its action as herein set forth.
