## RESOLUTION

## GIVING THE ADMINISTARTION AUTHORITY TO EXECUTE A SUPPLEMENTAL AGREEMENT FOR ADDITIONAL PROFESSIONAL SERVICES FOR THE 2023 RAISE GRANT PROJECT, COMPLETING DOWNTOWN LAUREL

WHEREAS, the City of Laurel has been awarded a United States Department of Transportation 2023 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary grant in the amount of \$24.8 million which requires no local match funding;

WHEREAS, the proposed project provides improvements to the east/west corridor along portions of 5<sup>th</sup> Street, Sawmill Road, and Teresa Street, including drainage, replacing deteriorated pavement, reconfiguring lane changes, lighting enhancements, landscaped medians, new ADA compliant sidewalks and a new roundabout;

WHEREAS, a Grant Agreement has been executed with MDOT and FHWA for the project;

WHEREAS, Neel-Schaffer has been selected by the City as the Engineer for the project and has submitted a contract to the Mississippi Department of Transportation for their review and approval;

WHEREAS, the City Council approved a contract with Neel-Schaffer pending concurrence from MDOT in the amount of \$1,517,060.29 on October 8, 2024;

WHEREAS, Neel-Schaffer has been requested to provide a restricted appraisal report during the preliminary engineering design phase for estimating the right-of-way costs of approximately 58 parcels;

WHEREAS, Neel-Schaffer has been requested to provide camera inspection for approximately 7,000 linear feet of gravity storm drainage pipe and approximately 5,000 linear feet of 6"-12" diameter gravity sewer mainline;

WHEREAS, the Supplemental Agreement has been submitted to MDOT for concurrence and approved for execution by the City in the amount of \$26,500.00;

NOW, THEREFORE, BE IT RESOLVED by the City of Laurel, Mississippi that:

- 1. The Administration is authorized to execute a supplemental agreement with Neel-Schaffer in the amount of \$26,500.00 to provide additional professional services for the 2023 RAISE Grant Project, Completing Downtown Laurel.
- 2. That the Finance Director is authorized to make any budgetary transactions necessary for implementation of the foregoing resolution.
