RESOLUTION

RESOLUTION GRANTING THE ADMINISTRATION AUTHORITY TO AWARD CONSTRUCTION OF THE CENTRAL AVENUE PHASE II – ROADWAY AND PEDESTRIAN IMPROVEMENTS PROJECT

WHEREAS, the City of Laurel proposes to construct improvements to the street and sidewalks along Central Avenue near 5th Avenue to Spec Wilson Boulevard;

WHEREAS, the proposed improvements include the removal of the failing brick surface and replacing with asphalt pavement, brick accented sidewalks and crosswalks, landscaping, curb & gutter, parking, lighting, and drainage improvements;

WHEREAS, the City was awarded up to \$1,750,000.00 in Federal Transportation Alternative (TA)

Program funds from the Mississippi Transportation Commission;

WHEREAS, the City has a required 20% local match of the construction costs and is responsible for all costs over and beyond the previously mentioned \$1,750,000.00;

WHEREAS, bids were received on Tuesday April 29, 2025, with two companies submitting bids;

WHEREAS, Walters Construction Company, Inc submitted the low bid of \$2,562,878.05 as shown on the attached bid tabulation;

NOW, THEREFORE, BE IT RESOLVED by the City of Laurel, Mississippi that:

- 1. The Administration is authorized to award construction of the Central Avenue Phase II Roadway and Pedestrian Improvements Project to Walters Construction Co. in the amount of \$2,562,878.05 contingent upon concurrence from the Mississippi Department of Transportation.
- 2. That Administration is authorized to execute all related documents in accordance with the MDOT Local Public Agency Project Development Manual.
- 3. That Finance Director is authorized to make any budgetary transactions necessary for implementation of the foregoing resolution.
