

## **ORDER**

### **REGARDING THE RATIFICATION OF AN EMERGENCY ORDER GIVING THE ADMINISTRATION AUTHORITY TO SUBMIT A DRINKING WATER SYSTEM IMPROVEMENTS REVOLVING LOAN FUND (DWSIRLF) APPLICATION FOR DRINKING WATER SYSTEM IMPROVEMENTS AND NAME THE MAYOR AS THE AUTHORIZED REPRESENTATIVE**

**WHEREAS**, on April 25, 2025, Mayor Johnny Magee issued an emergency order (see **Exhibit A**) giving the administration authority to submit a Drinking Water System Improvements Revolving Loan Fund (DWSIRLF) application for drinking water system improvements and name the mayor as the authorized representative

**WHEREAS**, §31-7-13(k) of the Mississippi Code of 1972 Annotated gives authority to the Mayor, acting as an agent of the City to order the immediate remediation of circumstances which threaten the safety and well-being of the citizens of the city, with ratification of said actions to be granted by the council at the next regularly scheduled meeting

**NOW THEREFORE, IT IS HEREBY ORDERED by the Laurel City Council** that the Emergency Order issued by Mayor Johnny Magee on April 25, 2025, a copy of which is attached hereto as **Exhibit A**, be ratified and that the following is authorized:

1. That the administration is authorized to prepare and submit an application to MSDH for funding of proposed facilities plan improvements through the DWSIRLF.
2. That the Mayor is authorized to execute and file an application and any amendments for a State Revolving Fund loan on behalf of the City of Laurel with full authority to execute all documents pertaining to the project.
3. That the Mayor is named the authorized representative of the project.

**IT IS FURTHER ORDERED**, that the Finance Director is authorized to take any action necessary for implementation of the foregoing Order.

Motion was made by Councilperson Carmichael, seconded by Councilperson Jordan, that the above and foregoing Order be adopted.
