ORDER APPROVING APPLICATION OF THE ESSMUELLER COMPANY FOR RENEWAL OF TAX EXEMPTION FROM AD VALOREM TAXES FOR THEIR FREEPORT WAREHOUSE AS AUTHORIZED BY SECTION 27-31-51 THROUGH SECTION 27-31-61 CODE OF 1972 AS AMENDED.

There came on for hearing this day before the Mayor and Council of the City of Laurel, Jones County, Mississippi, the sworn application of The Essmueller Company for renewal of exemption from ad valorem taxation for inventory values in their Freeport Warehouse located at 334 Avenue 'A' Airbase, Laurel, Mississippi, under provisions of Sections 27-31-51 through 27-31-61 Code of 1972 Annotated, as amended; the Mayor and Council of the City of Laurel having considered same and being fully advised in the premises finds as follows:

I.

That Essmueller South, Inc., a Mississippi Corporation, merged with The Essmueller Company, a Missouri Corporation, with Essmueller South, Inc. being the surviving corporation, and Essmueller South, Inc. then changed its name to the Essmueller Company.

II.

That The Essmueller Company is a corporation duly created and existing under the laws of the State of Mississippi and is presently doing business in Laurel, Jones County, Mississippi.

III.

That The Essmueller Company is a manufacturing concern, manufacturing processing, assembling and/or fabricating steel and other metal Products with a State of Mississippi license Freeport Warehouse in Laurel, Jones County, Mississippi.

IV.

That the exemption for renewal should be granted.

IT IS THEREFORE ORDERED, that the application of The Essmueller Company for renewal of an exemption from ad valorem taxation for inventory values in the Freeport Warehouse located at 334 Avenue 'A' Airbase, Laurel, Mississippi, be approved; that renewal of exemption is hereby granted, and that the inventory of The Essmueller Company certified as eligible with the State Tax Commission of the State of Mississippi be and it is hereby exempt from all ad valorem taxation as provided by law for a period of one (1) year from and after January 1, 2025.
