The Consultant Services Unit (CSU) has reviewed the following attached Supplemental Agreement No. 1 for a change in the Scope to provide a restricted appraisal report for estimating the right of way costs of 58 parcels, and camera inspection for gravity storm drainage pipe and sewer mainline Project between the City of Laurel (LPA) and Neel Schaffer, Inc. for the above referenced Project in the amount of \$26,500.00 for a revised maximum not to exceed cost of \$1,543,560.29. With the approval of the MDOT District LPA Engineer, the LPA may execute the SA at their discretion. Please also advise the LPA that any future SA's must be forwarded to the MDOT for concurrence before they are executed.

SUPPLEMENTAL AGREEMENT NO. 1

Laurel Raise Grant Jones County RAI-9399-00(004)LPA/109508-711000

WHEREAS, Neel-Schaffer, Inc. (the CONSULTANT) entered into the Engineering Services Contract with the City of Laurel (the LPA) on the 8th of October, 2024 to perform professional engineering services for the purposes of designing 1.8 miles along West 5th Street, Sawmill Road, Carroll Gartin Boulevard, North Magnolia Street, and Teresa Street from North 16th Avenue to the intersection of Teresa Street and Cross Street in Laurel, as provided for in Project No. RAI-9399-00(004)LPA/109508-711000 (the PROJECT); and,

WHEREAS, the LPA agrees that the CONSULTANT is entitled to additional compensation for Additional Services (Extra Work) as required by the LPA; and

WHEREAS, the CONSULTANT has been requested to provide preliminary appraisal costs as required by FHWA, resulting from a change in the scope of the project; and,

WHEREAS, the CONSULTANT has been requested to review the condition of the existing sanitary sewer system and storm drainage system by means of zoom camera inspection and mapping if determined that the system can remain in place as determined by a hydraulic analysis; and

WHEREAS, the CONSULTANT agrees to perform the Extra Work for an additional cost not to exceed \$26,500.00;

NOW THEREFORE, it is mutually agreed that the CONSULTANT will accomplish such Additional Services (Extra Work) in accordance with the Contract as modified herein and the LPA will compensate the CONSULTANT for services as follows:

Scope-0f-Work

The CONSULTANT has been requested to provide additional services related to the PROJECT which include: Provide a restricted appraisal report during the preliminary engineering design phases for estimating the right of way costs of 58 parcels. Provide camera inspection for approximately 7,000 linear feet of gravity storm drainage pipe and approximately 5,000 linear feet of 6"-12" diameter gravity sewer mainline.

The Maximum Allowable Cost shall be amended to add the sum of \$26,500.00 so the revised total Maximum Allowable Contract Cost is \$1,543,560.29. The total Fixed Fee shall remain the same at \$118,063.35. The new Maximum Allowable Cost is delineated below in the Fees and Expenses Schedule.

The above rate is an hourly port-to-port rate, meaning the clock starts when CES trucks leave the staging yard and the clock stops when CES trucks return to the staging yard. Standard Special Provisions

- The quantities shown in the fee schedule are estimates only, and CES will apply actual amounts collected during field
 operations to the fee schedule to determine final costs.
- Debris removed from the collection system will be properly transported to an approved and accessible waste disposal facility. The Client will provide this facility at no cost to CES; these fees do not reflect debris disposal costs.
- All manholes within the project area will be located and made accessible, at no cost to CES, by the Client. The Client shall facilitate physical, safe, and legal access to manholes needed for deployment to the pipeline to be inspected. The

Client shall open any sealed, vented, or other non-standard manholes and reinstall and reseal them as necessary after the inspection is complete.

- In the event that the entire length of a storm drain pipe is not visible during initial zoom inspection, an additional reverse inspection will be performed on that pipe from the opposite direction.
- In the unlikely event that equipment gets lodged in the collection system through no fault from CES crews, the Client will
 provide excavation services to retrieve the equipment at no cost to CES. The Client will complete the excavation of
 lodged items within 48 hours.
- The fees above do not include by-pass pumping. If by-pass pumping becomes necessary to complete the project, the
 rate will be negotiated on a case-by-case basis and agreed upon by the Client and CES.
- The Client will provide water for high-pressure cleaning operations at no cost to CES. The Client must provide fire
 hydrants within a reasonable distance of the cleaning site (500'). The Client and CES will negotiate and agree on the
 rate if a tanker truck is needed to transport water.
- Transmittal of this proposal in no way suggests, indicates, or guarantees a timeline for mobilization.
- This proposal remains valid for 30 days.
