Thence run S 33°53'08" W 12.96 feet to a magnetic nail, thence run S 09°35'47" E 22.05 feet to a magnetic nail on the Westerly right-of-way of Beacon Street, thence run N 33°06'01" E along said right-of-way, 28.93 feet to a magnetic nail, thence, leaving said right-of-way, run N 55°58'10" W 14.78 feet to the Point of Beginning. Containing 0.018 acre (770.78 Square feet).
