

## **ORDER**

(Ratifying Authorization of Attendance to Code Enforcement One Day Training Seminar in Atlanta, Georgia by a Member of the Inspection Department Staff)

**WHEREAS**, following the council meeting on May 8, 2018, the Inspection Department learned of the availability of a training seminar for Code Enforcement Officials in Atlanta, Georgia on May 18, 2018; **and**

**WHEREAS**, the Administration, recognizing that attendance at that educational opportunity by a member of the City's Inspection Department staff would be advantageous to the City of Laurel, authorized the enrolment by code enforcement official Sandra Hadley in the Code Enforcement One Day Training Institute; and

**WHEREAS**, the Laurel City Council now finds that the dispatch of Mrs. Sandra Hadley to attend the Code Enforcement One Day Training Institute was and will be in the best interest of the City

**NOW THEREFORE, IT IS ORDERED** by the Laurel City Council that the decision by the Administration to authorize the travel by Code Enforcement Official Mrs. Sandra Hadley to attend the Code Enforcement One Day Training Institute in Atlanta, Georgia on Friday, May 18, 2018; **BE IT FURTHER ORDERED** that funds in the amount of eight hundred, ninety-two dollars and sixteen cents (\$892.16) to cover the cost of registration, mileage, meals, parking, and lodging be taken from the Job Training account of the Inspection Department (#001-280-610.0); **AND FURTHER** that the Finance Director be authorized to perform whatever budget transactions are necessary for implementation of the foregoing Order.
