The City Council took up for consideration the matter of an amendment to Ordinance 1056-1985 which is

commonly known as "The Zoning Ordinance" and which regulates zoning within the City of Laurel.

The Inspection Department is recommending an amendment to APPENDIX I SECTION 602. GENERAL SIGN REGULATIONS to replace the words/reference of "Political Signs" with "Temporary Signs" and to replace the words or reference of "Religious Institution" to "Signs which are not related to residential use."

Whereupon motion was made by Councilperson Thaxton, seconded by Councilperson Wheat, for

approval of the first reading of the following Ordinance approving that amendment, the first reading having been

approved at a regular meeting on June 5<sup>th</sup>, 2018.

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Laurel that the

following ordinance be and the same is hereby adopted:

AN ORDINANCE OF THE CITY OF LAUREL, MISSISSIPPI, AMENDING ORDINANCE 1056-1985 TO ELEMINATE THE WORDS POLITICAL SIGNS AND "RELIGIOUS INSTITUTION"

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL of the City of Laurel, Mississippi:

SECTION I. That the following amendment be made to the Ordinance 1056-1985:

That APPENDIX I DEFINITIONS AND WORDS be amended by replacement of the definition of POLITICAL SIGNS, which currently reads:

**POLITICAL SIGN:** A temporary sign erected to publish the name of a candidate or to enlist votes in any official public election.

With:

Temporary Sign: A signed placed on a premise for advertisement, announcement or notice of a specific event which is to be removed within 5 days of the conclusion of that event.

## FURTHER

All references to signs as they relate to "Religious Institutions" shall be changed to "Signs which are not related to a residential use."

SECTION II. That all other sections of Ordinance 1056-1985 remain unchanged.

SECTION III. That this being its first reading, this Ordinance shall become effective one month from and

after its passage.

SECTION IV. The appropriate sections of the Laurel City Code shall be changed accordingly.
