WHEREFORE, Applicant prays that this Board enter a finding that applicant's factory is in fact a (____new __X__ expanded) enterprise of public utility, and that the same was completed on the 31st day of December 2017 within the meaning of the applicable laws of Mississippi; and

That applicant be granted an exemption from ad valorem taxation except School District and valorem taxation, as provided by law, for a period of 10 years beginning on the 1 day of January, 2018, upon all of the tangible property described in "Exhibit A" attached hereto and made a part hereof, used in, or necessary to the operation of applicant's factory in the City of Laurel, Jones County, Mississippi; and
