

## **RESOLUTION**

### **RESOLUTION GRANTING AUTHORITY TO CLOSE-OUT THE HEALTHY HEROES INITIATIVE #2 POLICE TRAINING ACADEMY WALKING TRACK**

WHEREAS, the Police Department has received a Healthy Heroes Grant to construct improvements to the existing walking track at the Police Training Academy;

WHEREAS, plans and specifications were prepared by Neel-Schaffer for the public bid of the project;

WHEREAS, bids were received on March 6, 2018;

WHEREAS, the City of Laurel entered into a contract with Tim Parker Construction, Inc. from Soso, MS, in the amount of \$166,798.45;

WHEREAS, Change Order No. 1 provided a pay item to compensate Tim Parker Construction for the additional work in the amount of \$2,324.80

WHEREAS, contract new total amount is \$169,123.25;

WHEREAS, Change Order No. 2 added 20 additional days to the contract to allow for the concrete walking track to cure properly and the rubber mat to be placed on the concrete surface,

WHEREAS, the project completion date changed from June 23, 2018 to July 13, 2018.

WHEREAS, Summary Change Order No. 3 shows the actual quantities used to complete the project;

WHEREAS, the project has been satisfactorily completed;

NOW, THEREFORE, BE IT RESOLVED by the City of Laurel, Mississippi that:

1. That authority is given to the Administration to accept close-out documents for the Healthy Initiative #2 Police Training Academy Walking Track Project.
2. That the Administration is authorized to execute Summary Change Order No. 3 for the Healthy Initiative #2 Police Training Academy Walking Track Project.
3. That the Administration is authorized to execute Final Payment (Retainage) in the amount of \$16,912.33 to Tim Parker Construction, Inc. for the Healthy Initiative #2 Police Training Academy Walking Track Project.
