

ORDER  
(Concerning the Re-Appointment of Several Members  
to the City Planning Commission)

**WHEREAS**, the terms of Mr. Jimmie E. Bunch, representative of Ward 4, Mrs. Judi Holifield, ex-officio representative of Laurel Main Street, Ms. Latonya Lewis, representative of Ward 6, Mr. Brad Kent, representative of Ward 3, and Mrs. Sandy Holifield, ex-officio representative from the Economic Development Authority of Jones County have expired; **and**

**WHEREAS**, those positions must be filled either by the re-appointment of current appointees or the appointment of new representatives; **and**

**WHEREAS**, each current member whose term on the Planning Commission has expired has expressed his/her willingness to serve an additional term; **and**

**WHEREAS**, the Planning Commission with its current constituency has served the citizens of the City of Laurel faithfully and well; **and**

**WHEREAS**, Ordinance 1340-1999 allows the re-appointment of a Planning Commissioner “at the pleasure of the Mayor”

**NOW THEREFORE, IT IS ORDERED** that upon nomination by Mayor Johnny Magee and approval by the Laurel City Council that the nomination for re-appointment be confirmed for the following:

Mr. Jimmie E. Bunch, as representative of Ward 4, with new term commencing immediately and expiring June 30, 2022

Mrs. Judi Holifield, as an ex-officio representative of Laurel Main Street, with new term commencing immediately and expiring June 30, 2022

Ms. Latonya Lewis, as representative of Ward 6, commencing immediately and expiring June 30, 2023

Mr. Brad Kent, as representative of Ward 3, commencing immediately and expiring June 30, 2023

Mrs. Sandy Holifield, as an ex-officio representative of the Economic Development Authority of Jones County, with new term commencing immediately and expiring June 30, 2023
