

**AMENDED INTERLOCAL AGREEMENT BETWEEN
THE CITY OF LAUREL, MISSISSIPPI,
THE CITY OF ELLISVILLE, MISSISSIPPI, AND
JONES COUNTY, MISSISSIPPI
FOR THE PURCHASE AND FINANCING OF A
MOTOROLA P25 COUNTY-WIDE RADIO COMMUNICATION SYSTEM**

This Amended Agreement entered into by and between the following parties: City of Laurel, Mississippi (herein “Laurel”); City of Ellisville (herein “Ellisville”); and Jones County, Mississippi (herein “County”) to wit:

WHEREAS, on or about September 4, 2012, the City of Laurel, City of Ellisville and Jones County entered into an interlocal agreement as relating to the purchase and financing of Motorola P25 county-wide radio communication system. See agreement attached hereto as Exhibit “A”; and

WHEREAS, Section 2 of said Interlocal Agreement inadvertently stated that Laurel would pay unto County forty-five percent (45%) of the annual lease payments; and

WHEREAS, Section 3 of said Interlocal Agreement inadvertently stated that Ellisville would pay unto County ten percent (10%) of the annual lease payments; and

WHEREAS, Section 2 should have stated that Laurel would pay unto the County 23.55% blended with interest to 23.79% of the annual lease payments; and

WHEREAS, Section 3 should have stated that Ellisville would pay unto the County 7% blended with interest to 7.07% of the annual lease payments; and

WHEREAS, all terms of said Interlocal Agreement, shall remain except the percentages stated in Section 2 and Section 3.

NOW THEREFORE, in consideration of the mutual agreements herein and the mutual relationship of the parties as they relate to the Motorola P25 county-wide radio communication system, the parties agree to amend the said Interlocal Agreement as follows:

Section 2.

Laurel agrees to pay unto the County 23.55% blended with interest to 23.79% of the annual lease payments.

Section 3.

Ellisville agrees to pay unto the County 7% blended with interest to 7.07% of the annual lease payments. These percentages shall be retroactively applied to the effective date of the original Interlocal Agreement.
