

## **RESOLUTION REGARDING LAUREL DOG PARK SPONSORSHIP**

**WHEREAS**, the Jones County Leadership Team aka “Leader of the Pack” (hereinafter “Sponsor”) wishes to sponsor the dog park being built in Mason Park; and

**WHEREAS**, Sponsor has secured funds from Raising Cane’s Restaurants, LLC (hereafter, “Raising Cane’s” or “Benefactor”) for certain enhancements to the Laurel Dog Park; and

**WHEREAS**, in exchange for Benefactor’s contribution of \$11,000.00 for fencing and signage to be secured by the Sponsor for the dog park, the City of Laurel agrees for a five (5) year period to name the dog park the “Raising Cane’s Chicken Fingers Laurel Dog Park” and to place signage and do the items as described in Exhibit “A”;

**NOW, THEREFORE, BE IT RESOLVED** that the City of Laurel hereby accepts the donation as described above by the Sponsors and hereby names said dog park the “Raising Cane’s Chicken Fingers Laurel Dog Park” and agrees to the items in Exhibit “A” attached hereto.

## **EXHIBIT “A”**

The City of Laurel shall:

- Place a sign displaying the name of the dog park at the North entrance of Mason Park on 7<sup>th</sup> Avenue.
- Place a directional sign with Raising Cane’s Chicken Fingers trademark prominently on said sign by the West side of the walking bridge directions pedestrians to the dog park.
- Place a sign recognizing donors for project at the entrance of both large and small dog park entrances.
- Place Raising Cane’s Chicken Fingers trademark at the top of the dog park rules signs which shall be posted on both the large and small dog park fences near the entrances of said park.
- The cost of the above described signage is being provided by the Jones County Leadership Team
- The City of Laurel shall erect said signs within three (3) months of receiving the donation from Sponsor.
- The City of Laurel shall be responsible for the cost of replacing signs due to funding or damages for a period of five (5) years.
- The City of Laurel agrees that Raising Cane’s shall be included in special events hosted by the City of Laurel in the Dog Park such as ground-breaking ceremony and/or ribbon cutting, grand opening event and holiday events.
- The City of Laurel shall place Raising Cane’s name and/or logo on the City of Laurel’s website concerning the Dog Park.
- The City of Laurel agrees that Raising Cane’s will have access to host special events at the Dog Park in coordination with the City of Laurel.
- The City of Laurel agrees that Raising Cane’s is hereby given a first right of refusal to renew benevolent support of the dog park at the expiration of five (5) years upon the City of Laurel’s standard sponsorship terms.
