

**RESOLUTION**  
**In Support of the Pearl River Valley Opportunity, Inc. Rehabilitation**  
**Efforts inside the City of Laurel**

**WHEREAS**, the City of Laurel has as a stated goal the assurance of decent, affordable housing and safe neighborhoods for low- and moderate-income families; and

**WHEREAS**, assessment of Laurel's neighborhoods has determined that there are areas of the City in which there is a concentration of homes that need to be repaired or replaced in order to provide a safer and more decent environment for low- and moderate-income families; and

**WHEREAS**, the City of Laurel wishes to place a priority on the rehabilitation of homes in those blighted areas as a part of its Neighborhood Stabilization and Revitalization efforts, and

**WHEREAS**, the City of Laurel has by resolution of May 8, 2018 identified certain Census Tracts in which there was a concentration of sub-standard housing; and

**WHEREAS**, Pearl River Valley Opportunity, Inc. (PRVO) owns 34 houses in the Oak Hill Subdivision, located in Ward 1 of the City of Laurel and also located in Census Tract 9506, which tract is included in the City of Laurel's Neighborhood Stabilization and Revitalization Plan; and

**WHEREAS**, the City of Laurel desires to support PRVO in its partnership with The First, A National Banking Association in their application to the Federal Home Loan Bank of Dallas, in seeking funds in the amount of at least \$340,000 to renovate the 34 houses in the Oak Hill Subdivision; and

**WHEREAS**, this support from the City of Laurel, includes no monetary commitment to PRVO or The First.

**NOW THEREFORE, BE IT RESOLVED** that the City of Laurel affirms its support of PRVO in this rehabilitation effort inside the City of Laurel, MS.
