## AUTHORITY TO INITIATE THE CENTRAL AVENUE IMPROVEMENTS PROJECT

WHEREAS, the City of Laurel proposes to design improvements to the street and sidewalks in the 500 Block of Central Avenue:

WHEREAS, the proposed improvements include the removal of the failing brick surface and replacing with asphalt overlay, brick accented sidewalks and crosswalks, landscaping, curb & gutter, parking, and drainage improvements;

WHEREAS, the design will be cohesive with the design of previously approved projects that are adjacent to the project area;

WHEREAS, the City applied for funding approval of a Transportation Alternatives Fast Act

Project for the Central Avenue Improvements – 500 Block Streetscape project from MDOT;

WHEREAS, the City was awarded \$344,100.00 in Federal Funds from MDOT;

WHEREAS, the City of Laurel requests that the Mississippi Department of Transportation initiate the Central Avenue Improvements Project and include this project in Federal Aid Project No. STP-8080-00(004)LPA/107371-701000 Intersection Improvements Project – Central Avenue at 5th Avenue Roundabout, described herein;

WHEREAS, the preliminary engineering costs will be paid by the City of Laurel; and WHEREAS, the City of Laurel understands that the total Federal Funds available for the combined project is \$868,740.00;
