The City of Laurel Parks & Recreation Department shall:

Provide the following for Raising Cane's Corporate Field and Dugout Sponsorship:

Raising Cane's Chicken Fingers® logo on (1) 12' x 60' center field fence banner

Full Page ad in 2020 Dixie Youth World Series Souvenir Program

- The City of Laurel Parks & Recreation Department shall acquire, install, and maintain all signage contemplated by this Agreement at its own cost.
- The City of Laurel Parks & Recreation Department shall be responsible for the cost of replacing signage due to funding or damages for a period of five (5) years.
- The City of Laurel Parks & Recreation Department agrees that Raising Cane's will have access to host special events at the Sportsplex Baseball Facility in coordination with the City of Laurel Parks & Recreation Department Representative.
- The City of Laurel Parks & Recreation Department agrees that Raising Cane's is hereby given a first right of refusal to renew its sponsorship at the termination of the present five (5) year sponsorship based upon the City of Laurel's sponsorship terms.
